# VISA FIFA CUSCAL PROMOTION

## Terms and Conditions

### HOW TO ENTER

To be automatically entered into the draw, individuals must spend a minimum of \$20 in a single transaction on their Visa Debit card (by using the 'credit' function) between 05/02/10 and 5:30pm AEST on 25/04/10.

### TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 16 years or over who have a valid passport as at 09/05/10, which will have at least six months validity remaining from 21/06/10.
